**PUBLIC NOTICE**

**REGISTRATION OF PRODUCERS, IMPORTERS & BRAND-OWNERS (PIBOs)  
AND PLASTIC WASTE PROCESSORS (PWPs) ON CENTRALIZED EXTENDED  
PRODUCER RESPONSIBILITY (EPR) PORTAL FOR PLASTIC PACKAGING**

Ministry of Environment, Forest & Climate Change (MoEF&CC), Govt. of India, notified guidelines on Extended Producer Responsibility (EPR) for plastic packaging vide fourth amendment to Plastic Waste Management (PWM) Rules on February 16, 2022. Accordingly, the Centralized EPR Portal (<https://eprplastic.cpcb.gov.in/#/plastic/home>) has been launched by CPCB to register Producers, importers & Brand Owners (PIBOs) who are operating in more than two States with CPCB and those operating in one or two States/UTs shall be registered with the concerned State Pollution Control Boards (SPCBs)/Pollution Control Committees (PCC). Plastic Waste Processors shall also have to register with the concerned SPCB/PCC in accordance with the provisions of the Section 13(3) of the Plastic Waste Management Rules, 2016 on this centralized portal.

This notice is being issued to inform all the PIBOs & PWPs operating in Andaman & Nicobar Islands who have not yet applied for are requested to submit registration application complete in all aspects on the EPR Portal within 2 weeks to CPCB/Andaman Pollution Control Committee (as applicable) in accordance with the provisions of PWM Rules 2016 as amended.

Necessary action, as deemed appropriate under the Environment (Protection) Act, 1986 including levying of Environmental Compensation and closure of operations shall be taken against defaulters.
